

# Background

### Using Quadruple Bottom Line methodology devised by Dr. Iyer

Investment: Rs.7 lac + GST Time frame: 2 to 4 months



### CSR compliance and integration with business model

- Ensuring CSR compliance as per the laws including impact assessment & reporting
- Integrating CSR vision and milestones with the business model to ensure deep connect with local communities leading to optimal utilisation of CSR funds

Investment: Rs.3 lac + GST Time frame: 1 to 2 months









 Getting organic print & digital media coverage for the cos. for publicity and outreach for the work carried out by company and impact created with customers, local communities and Society

Investment: Rs.2 lac + GST

Timeframe: 3 months engagement



## Fund Raising & Awards initiatives

- Engaging with ESG Fund Managers and Funding Agencies such as World Bank, Asian Development Bank (ADB), USAID, etc. for access to ESG capital in the form of soft loans, grants, and equity investment in the company
- Identifying national & international awards and applying for the same



Investment: 3% to 9% of the funding amount raised based on size and nature of funding post completion of impact assessment study and publishing of sustainability reporting

Awards: Award prize money will be equally distributed 50-50 with the company irrespective of the amount raised
