Documents required:

- I. In case applicant is owner No Objection certificate (NOC) original copy from Author is required.
- II. In case of unpublished work, application is to be accompanied by two copies.
- III. Application for computer programme should be accompanied by source and object code.
- IV. In case of Cinematograph Film NOC (s) from various Copyright holders is mandatory or submit assignment deed / agreement. In original or notarised, else application will be rejected.
- V. In case of Sound Recording NOC (s) from various Copyright holders is mandatory or submit assignment deed / agreement. In original or notarised, else application will be rejected.
- VI. (a) In case of Artistic work that is used or capable of being used in relation to any goods, such application shall include a statement to effect and shall be accompanied by a certificate (TM-60) from the Registrar of Trademarks, to the effect that no trademark identical with or deceptively similar to such artistic work has been registered under the Trademark Act, in the name of or any person other than applicant.

(b) In, case of Artistic capable of being registered as a design under the Design Act 2000, such application shall be accompanied by a statement in the form of **Affidavit** containing the following, namely:-
 - 1) It has not been registered under the Design Act, 2000
 - 2) It has not been applied to an article through industrial process and reproduced more than 50 times
